Dear Senators McAuliffe, Tom, and King:

Thank you for your March 12 letter concerning the State Board of Health's efforts to modernize its school environmental health and safety rules. The full Board will discuss your request at its next regularly scheduled meeting on May 14.

As your letter mentioned, the Board is hosting a series of workshops to ensure the technical clarity of the final published draft. There was considerable uncertainty about how to interpret earlier discussion drafts. As a result, efforts to estimate costs for complying with those drafts, while conducted in good faith, often bore little relationship to the intent of the rule. The workshops are intended to eliminate confusion that stems from unclear language and to clearly articulate remaining areas of substantive disagreement.

The Board considers both benefits and costs in all its rule deliberations and welcomes any opportunities to discuss the potential fiscal impacts of its rules with the Legislature and the Office of Financial Management. The Department of Health (DOH) has begun working on a significant rule analysis and will be refining it as agreements emerge from the workshops.

All of the parties in this rule development process share a common commitment to safe and healthy school environments. These parties include the Legislature, state agencies, local health jurisdictions, school districts, school employees, and parents. What we do not have yet is a common understanding of the rule's impacts and associated costs. By the end of April, we will have made considerable progress in clarifying intent. By the end of May, we should have a much clearer picture of possible fiscal implications.

I look forward to future conversations between the Board and interested members of the Legislature—such as yourselves and the other members of your committee—about ways
