WASHINGTON STATE BOARD OF HEALTH WATER RECRECATION FACILITIES AND RECREATIONAL WATER CONTACT FACILITIES RULEMAKING SUMMARY AND TIMELINE

Background

The State Board of Health (Board) is considering updating the <u>Water Recreation</u> <u>Facilities</u> and the <u>Recreational Water Contact Facilities</u> rules to align the rules with the Center for Disease Control and Prevention's (CDC) Model Aquatic Health Code (MAHC), clarify regulations on inflatable equipment, keep pace with changing water recreation technologies, and to improve clarity and useability of the rules.

Purpose

The current rules regulate water recreation and recreational water contact facilities such as swimming pools, spas, hot tubs, splash pads, water parks (including slides, lagoons, and lazy rivers), natural designated swim areas, and more. The rules aim to keep the public safe by outlining requirements related to permits for construction and operation, operating plans, water quality standards, inspections, equipment, emergency response, and personnel training.

In December 2016, the Board filed a CR-101, Preproposal Statement of Inquiry, to explore possible updates to these rules. The scope of the rulemaking includes statutory requirements to consider the most recent version of the MAHC and exemptions on inflatable equipment operated at temporary events and considers the consolidation of these two chapters into one to improve clarity and useability. These rules have not been substantially revised since 1991, and rulemaking is intended to update these regulations with best practices and industry standards.

Next Steps

The Board is working closely with the Department of Health to identify possible revisions to chapters 246-260 and 246-262 WAC and convene a technical advisory committee to provide input on proposed revisions. Staff will send rulemaking updates and ways to be engaged to the Board's interested parties list and post updates on the Board's Water Recreation Rulemaking webpage.
