

August 7, 2024, Board Meeting Recap

The State Board of Health (Board) met on August 7, 2024 (<u>watch the recording</u>). After attending to the business of approving the <u>agenda</u>, adopting <u>minutes from the June 12</u>, <u>2024 meeting</u>, and receiving public comment, the Board received updates on the following topics:

- The Board considered a <u>petition to add Wilsons Disease to the Newborn</u> <u>Screening panel</u> and directed staff to convene a Technical Advisory Committee (TAC).
- Brad Finegood, Strategic Advisor at Public Health Seattle & King County, shared a presentation about Overdose Prevention and Response (<u>View Brad's</u> <u>presentation here</u>).
- Board staff Andrew Kamali and Department of Health staff David Delong briefed the Board on <u>Yakima</u> and <u>Cheney</u> Water Recreation Variance Requests. The Board will hold a special meeting (TBD) to allow more time to review the requests and to provide a timely response to the requester.
- The Board considered and declined a <u>petition regarding On-site Sewage</u> <u>Systems Holding Tanks</u>.
- The Board's Health Impact Review (HIR) team shared a Fiscal Year 2024 update (View HIR presentation here).
- Michelle Davis, Executive Director introduced new project staff <u>Kelly Kramer</u>, <u>Newborn Screening Policy Advisor</u>, and the <u>School Rule Project team</u>. Executive Director Davis also provided an update on rulemaking activities since the last meeting.
- Board staff Andrew Kamali provided an update on the <u>School Environmental</u> <u>Health and Safety Rule Project</u> and the Technical Advisory Committee's (TAC) August 1, 2024, meeting.
- Board staff Kelly Kramer and Department of Health staff John Thompson briefed the Board on the addition of Ornithine Transcarbamylase Deficiency (OTCD), Guanidinoacetate methyltransferase (GAMT) deficiency, and Arginase 1 Deficiency (ARG1-D) to the Newborn Screening panel.
- Board Member Paj Nandi and Board staff Ashley Bell shared an update on Pro-Equity Anti-Racism (PEAR) planning (<u>View PEAR Plan presentation here</u>).
- Board Member Tao Sheng Kwan-Gett introduced the Department's Be Well Washington initiative and will provide additional information at a future meeting.
- Board Member Socia Love noted that Puyallup Tribe of Indians recently hosted the landing for the annual <u>Canoe Journey</u>. This year's theme was Our Sacred Youth. Member Love described the event and encouraged the public to attend in the future.

The next Board meeting will be held on October 8, 2024, in Yakima, WA. Board staff will distribute a draft agenda on September 24.
